**Publicity:** Sue Rankin asked for a Publicity volunteer to write the monthly Sunland Village Journal article.

Ryan responded to questions from the floor regarding Sunland Village course rules. He discussed having your ball go into the bushes by the maintenance building during play. You can take an unplayable lie with a one stroke penalty. You may move your club two club lengths from the bushes. You could go back to the tee and re-tee the ball. You will then by hitting three. If you move your ball to the fairway in line with where your ball landed in the bushes, you will be hitting 4 – does not apply to an unplayable lie, only applies to a lost ball or ball out of bounds.

If you are playing the 16<sup>th</sup> hole and your ball goes over the green and into the water, the ball can be moved to the 14<sup>th</sup> hole side of the pond or to the drop area. You could also retee your ball. When in doubt go to the drop area.
