Sunland Village Golf Association recognizes 3 leagues from within our association: The Men's, the Ladies, and the Couples. We have designated days that we play. The Men play 18 holes at 8 am and 11 am on Monday/Wednesday, their designated days (and some men play 9 holes). The Ladies play 18 holes at 8 am and 9 holes at 11 am on Tuesday/Thursday, their designated days. The Couples are playing on Saturdays.

I have been told that some women do not want to belong to our league. They want to play 18 holes on their own. You do not have to belong to our Ladies League if you do not want to. Simply do not pay your league dues (\$40). These women are welcome to create their own league. They can book their own tee times (not within our league times), keep their own scores and handicaps. They will not be eligible for the hole-in-one pots and, of course, Mike works for Sunland Village Golf Association, so they would not be able to utilize his services or his expertise.

There are several leagues that play at Sunland that are not part of the Sunland Association. There is nothing stopping any group of ladies from forming their own league. It just won't be a recognized Sunland Village League.
